

## COMVOZ PRIVACY POLICY

The terms and conditions that govern the use of the COMVOZ Electronic Platform are described below:

Comvoz Communication, LLC (COMVOZ) a limited liability company organized under the laws of the state of Florida on August 02,2002

A- duly organized company domiciled in 75 VALENCIA AVE SUITE 703, CORAL GABLES, FL 33134

### 1.- INFORMATION COLLECTED:

COMVOZ may collect information about the users of its website, such as: sections in which they enter or frequency with which they visit its page. Such information is obtained automatically, is anonymous and is used without identifying any user individually. This information allows NETUNO to analyze the traffic on its website and adapt its contents to the needs of users.

On the other hand, it may require users to send their personal identification, such as, for example: name, address, email address, nationality, age, sex; The objective pursued, when collecting this information, among others, is to facilitate the task of offering content and customer service, network management, customer surveys, subscriptions, offers of related services, billing and other exchanges of information from their website.

COMVOZ will not reveal or share this information with any other company or organization without the prior consent of the user who provides said information, except when established by law at the request of any administrative or judicial body.

It is understood that a user's messages or notices posted on any message board or screen or in any space for the exchange of "chat room" conversations will not be protected as confidential information, under the terms established in this privacy policy, therefore that NETUNO may use the information contained in said notices for any purpose it considers appropriate.

### 2.- USE OF THE INFORMATION COLLECTED:

COMVOZ will use users' personal information, as indicated above, to send them information about the products and services it offers. Users may choose not to receive such shipments in the future, notifying it through the Contact section, located on the website; It is expressly understood that this practice will not be considered spam.

On the other hand, COMVOZ may use the information of the users of its website to determine their demographic data, distribute statistical information and, in general, the market to which it provides services. These demographic data always represent aggregate information and never identify a specific user.

Users' personal information will not be revealed by NETUNO to any other natural or legal person, subject to the provisions of the penultimate paragraph of the first point above.

### **3.- COOKIE:**

A "cookie" is a small data file that some websites write to the hard drives of users who visit them. A cookie file may contain certain information such as the user ID that the site uses to track the pages you have visited; however, the only personal information that a cookie can contain is information that the users themselves provide. A cookie cannot read data from users' hard drives, nor read cookie files created by other websites.

The COMVOZ website may use cookies to track user traffic patterns. If the user has adjusted their browser to warn them before accepting cookies, they will receive the warning message with each cookie; In which case, the user may refuse to accept cookies by deactivating them in their browser. It is understood that the user will not need to have cookies activated to use the COMVOZ website; however, if the user refuses to accept cookies, there is a possibility that the user will not have access to certain sections of the site.

### **4.- PROHIBITION OF SHARING INFORMATION:**

COMVOZ will not share users' personal information with any natural or legal person; however, it may share statistical information about the use of the site in order to better adapt its contents to the needs of users.

### **5.- USER OPTIONS TO RECEIVE OR NOT RECEIVE INFORMATION:**

If for any reason, COMVOZ decides to collect and use users' personal information, for any purpose not listed above, COMVOZ will inform users in advance about the use of said information, in the corresponding electronic form.

As indicated above, COMVOZ may use the user's information to send the user information about the products and services offered by COMVOZ, a practice that cannot be considered "spam", as explained above.

Users may choose not to receive future correspondence, notifying this option through the Contact section, as indicated in section 2.

### **6.- USER OPTIONS TO MODIFY THE INFORMATION SUPPLIED:**

COMVOZ offers users the possibility of correcting or changing the information previously provided by them. Instructions for doing this can be found in the updating data section. Users may change this information at any time and as often as necessary.

### **7.- SECURITY:**

The COMVOZ website uses secure connections and other security measures designed to safeguard the confidentiality of user information, as explained in the general conditions of use.

**8.- MODIFICATIONS TO THE PRIVACY POLICY:**

The modifications to the privacy policies stated here will be made by COMVOZ in accordance with the provisions of the general conditions of use, and will be published on the website, coming into effect at the time indicated by COMVOZ from time to time.

**9.- FINAL PROVISIONS:**

It is expressly understood that anything that is not expressly provided for in these policies, the provisions established in the general conditions of use of the COMVOZ website will apply.
